TRANSIT IMPACT FALL 2012 DTA CONFERENCE BY CHERYL JONGERIUS, DICKEY COUNTY TRANSPORTATION

One of the sessions at the DTA Conference in Brookings was called "Transit Impact in the Dakotas" and featured 2 speakers.

The first speaker was Dave Ripplinger who shared insights from his study through the Upper Great Plains Transit Institute at NDSU titled "Organizing Transit in Small Urban and Rural Communities" Two of the findings Dave shared from his study included that provision of transit across a large rural region by one provider was not found to necessarily be economically efficient. This finding does not align with conventional wisdom of consolidating smaller transit agencies into a single operating agency. One of the other findings was that across the rural transit network there was an excess capacity of rolling stock.

The second study was shared by Bruce Lindholm of the South Dakota Department of Transportation. The full study that was completed in December 2011 is called "Costs and Benefits of Public Transit in South Dakota." One of the main points of the study was to measure the economic impact that public transit provides. The study found that for every dollar spent on public transit in the state generated \$1.90 of economic activity. We received a brochure that summarizes the study - "Public Transit in South Dakota – It's more than Transportation" This brochure and study was referenced in an earlier edition of "Transit Tidbits this year." BUS BURNING BY MIKE MULLANEY BROOKINGS AREA TRANSIT ASSOCIATION

Have you ever pondered what would happen if a bus you were driving caught on fire? Would anyone come to your aid? How long would you have

to get yourself and your passengers to safety? These questions were answered at the 2012 DTA Conference held in Brookings, SD. With a little help from the Brookings Volunteer Fire Department, attendees of the conference witnessed first-hand just how quickly a nice drive could turn into a horrible nightmare.

After a refresher course in first aid and the use of fire extinguishers, the fire chief struck a match and initiated the much anticipated bus burning. Spectators quickly backed up as the flames were much hotter than they had expected. The flames had fully engulfed the bus within less than a minute and a thick black smoke rolled upward filling the air. Ten minutes later, the fire had dwindled and was extinguished.

I'm not sure the onlookers of this demonstration were prepared for just how quickly this bus was consumed in flames- I know I wasn't. There was no talking or noise except for the roar of the fire. As the fire subsided, there was suddenly an uneasy feeling surrounding us. Spectators began to chatter about what they had just witnessed. About being in their home towns, doing the jobs they enjoy daily, and what their reaction would be if a fire occurred in the bus they were driving.

What could you do all by yourself in one minute? Would the bus already be destroyed by the time help arrived? These are scary, but real questions that we hopefully will never have to encounter first-hand. We would never want a fire on our bus or harm to come to our passengers. We all strive to be good, defensive drivers who try to keep clear of accidents. But what if an accident did happen? How would you react?

FRANK CONDON RTAP WEBSITE BUILDER BY MISTY CURN, BIS-MAN TRANSIT

Transit agency directors and employees are overwhelmed with a large variety of tasks, so marketing can easily fall by the wayside, especially for rural providers. RTAP (Rural Transit Assistance Program) not only provides financial assistance for rural transit providers, but also has other resources, including a newly launched Website Builder that allows rural agencies to create and host free web sites.

Frank Condon, technical support specialist for the RTAP Website Builder, shared information about the program during one of the DTA Fall Conference sessions. He provided insight about the capabilities and shared examples of web sites that have been created using the program.

Several agencies in North Dakota and South Dakota have been working on getting their sites established and the new DTA web site that will be launching soon was also created using the RTAP Website Builder. The program is easier to use if the designer has some knowledge and background in web design, but tutorial videos online can help guide the novice designer through the process.

MARKETING PANEL SESSION BY RANDY HARTMAN SIOUX AREA METRO

Though Sioux Area Metro has been a member of DTA for some time now, I am new to DTA and am a new member to the Board, replacing Karen Walton. Karen had asked me if I would take her place on the Board. She said the people who belong to DTA are a good group of people and I would really enjoy being a member and working with them. I accepted her offer to replace her on the Board and the DTA Board members have welcomed me with open arms! The DTA Fall Conference is the first DTA conference I have attended and am very thankful I went. Due to scheduling conflicts, I was unable to attend all of the sessions, but I was able to attend the Marketing Panel Session. The Marketing Panel consisted of Moderator; Scott Brogren (CTAA), Misty Curn, Kristin Heismeyer and Mike Mullaney, all members of DTA

Many ideas and suggestions were presented during the session from the members of the Marketing Panel. Some of the ideas and/or suggestions are as follows:

• When creating a web page, brochures, posters, etc. to market our transit services, we should use only one font for the printing and not use several different fonts to try to attract attention to the web page, etc. Also, when creating the web page, leave "white space" between notices, paragraphs and statements to allow the eyes to rest between readings. A "busy" or overcrowded page can discourage someone from reading it and they may possibly miss the message you are trying to get

across. Also the color of paper and the color of the font are very important. Example: white lettering on black paper or red paper is difficult to read. It was suggested to stay with the basics of black or a dark color of lettering on a lighter shade/color of paper for more easily readable material.

- To encourage children to get involved with public transit, have them "name a bus". Children can give names to buses and possibly have the child's poster displayed in the bus. This gets parents, grandparents, and other family members involved in public transportation and possibly new riders and supporters!
- Going above and beyond in providing exceptional customer service is a goal that I consider extremely important. A company, whether it's private or public, relies on excellent customer service to get people to support the business or to ride the bus. 'Word of Mouth' is one of the best marketing tools we have! If we provide a reliable, friendly and convenient service, and go beyond what is expected to satisfy the customers, those customers will continue to ride and support public transportation and spread the good word!
- I appreciated the suggestion that we should be thankful to the people who support public transportation. If you respect and appreciate the support from members of the community you serve, City officials, government officials or anyone else who supports you and public transportation, write them a thank-you note! Let them know how thankful you really are!

There were several other suggestions and ideas mentioned during the Marketing Plan session and I could go on and on but I just wanted you to get an idea of what we discussed.
