As with most media reports, some detailed information was not included—this Rabbit Ride program is run only on Friday and Saturday evenings from 9:00 PM to 2:30 AM and is free to passengers. Not all transportation here is free. The Tap Ride App is new to the program as highlighted. Securing the app was a move to draw more interest to the service and work with student’s technology demands. The ridership numbers for this program have ebbed and flowed over the years, with the past few years being low – of course, Covid was the greatest impact over the past year. Many factors come into play with this ridership to include:

How does a transit organization end up with a corporate name like Nutrition United? Well, it all started a long time ago, in a County far, far up north. In 1973, various organizations in Rolette County began exploring the possibility of having a nutrition program in, which was quite a challenge as it has made the top 50 counties list in the country when it comes to poverty level. Roger Wetzel, who was then the Regional Aging Services Coordinator, shared several specific requirements and questions to think about.

In 1975, this led to the formation of a single organization to develop a nutrition program. The organization that formed as a result was Nutrition United, Inc., incorporated on May 27th, 1975. Nutrition United began services on May 25, 1977 with the Rolette County Meals Program (RCMP). Across the line RCMP meant something else, not that transit would ever want to tangle with the Mounties, those old 440 Dodges were good for a buck forty and change.

The year 1978 brought expansion of services for Nutrition United with the provision of transportation services. Rides started on November 14th, 1978. The first vehicle was a 1973 Ford van that was received by Nutrition United in a transfer of inventory from the Golden Age Mini-Bus Project which was no longer being operated due to the dissolution of the Rolette County Senior Citizens Council, one of the agencies involved with the development of Nutrition services and were already in the transit business before the formation of Nutrition United.

This small (for the time) van was among the 1st handicapped equipped vehicles of this type purchased in the state of North Dakota by an operation such as ours. Funds for this purchase was actually provided thru the Older Americans Act. The idea for a handicapped vehicle came from the old Ironsides TV program (was that Raymond Burr's role before or after Perry Mason?). Expansion of services contributed to evolving Rolette County Meals Program into



the Rolette County Senior Meals and Services programs and the Rolette County Transit program, (had thought about Rolette Area Transit, but wasn't so hip on the acronym).

In 1979 Nutrition United purchased its second vehicle, a 1979 Dodge van with a grant from the State Highway Department with UMTA funds (remember those), which started us down the path with what is now FTA.

Fast forward to the present and unfortunately, we're still an economically challenged area, far away from many of major centers, but still filled with that same desire to overcome that by getting folks where they need to go, covering a quarter of a million miles a year (and wearing out a vehicle) in the process.

Another challenge in our area is a high rate of Diabetes/Kidney Disease. When we first started transporting to Dialysis, they had four machines operating 3 days a week. Now they have a dozen running six days a week, and there's still a demand. We actually think of this as a local ride even though the clients may be coming from an hour away. We're heading southeast a couple days a week connecting to Grand Forks and Fargo and Southwest a couple more days to Minot and Bismarck. This is just some of the scheduled stuff, still carrying on the mission that began almost 50 years ago with that first van.
